SECTION 5: Minister's Covenant

The office of a Malaysian Foursquare minister is a sacred trust given by the Board of Directors, in accordance with the will and calling of God. And having been recommended by a committee member and approved, according to the Bylaw of this Church, by the Board of Directors, all Ministers shall:

- 1. Devote themselves to the worship of the Almighty God, to the study and presentation of the Word of God to as many as possible and to personal purity and maturity as a believer in Jesus Christ;
- 2. Give themselves to the evangelization of their communities and church planting; striving toward salvations, water baptisms, healings, baptism into the Holy Spirit, and creating fervent expectation of our soon-coming King.
- Through preaching, teaching and servant-leadership, dedicate themselves to the equipping and developing of each member of the congregation into a minister of the Lord Jesus Christ.
- 4. Nurture the development and release of new spiritual leaders;
- 5. Join in the Great Commission by encouraging financial, physical and prayerful support of The Foursquare Gospel Church;
- 6. Promote unity in FGC by striving to develop deep and meaningful relationships with fellow leaders and joining ministers and leaders function as often as possible;
- 7. Represent and strengthen the God-given distinctive of the Malaysian Foursquare Gospel Church, its goals and ministries;
- 8. Give one half of their monthly tithe to The Foursquare Gospel Church National Office in support of the collective functions of the church, and collect one extra offering each month from their every church or outreach in support of the same;
- 9. Participate in the yearly National Conference whenever possible for unity, personal edification, conduct business when appropriate, and election of directors during election years;
- Recognize their right to serve as Malaysian minister in this movement requires they must not only possess, but keep current and in good standing credentials provided by this Board of Directors;
- 11. To improve their ministry, they are willing to take further reasonable training as Recommended by the Board of Directors, and a polity course at earliest convenience within 12 months of appointment as a minister of FGC.
